#### **APPENDIX A: State Legislative Bills**

#### HB 1888: Protecting employee information from public disclosure.

Sponsors: Hudgins, Valdez

Summary: Exempts month and year of birth, photographs, and payroll deduction information of government employees and volunteers held in certain personnel files from public disclosure, but permits the news media to have access to full dates of birth and photographs. Exempts personal demographic details of individual state employees from public disclosure. Requires a governmental entity to provide notice when a records request has been made for information exclusively in an employee's personnel, payroll, supervision, or training file.

Senate Passed: 36-10-0-3 (3/4/20) House Passed: 91-5-0-2 (3/9/20)

### HB 1521: Providing for accountability and transparency in government contracting.

Sponsors: Dolan, Harris, Valdez, Frame, Caldier, MacEwen, Griffey, Blake, Sells, Tarleton, Fitzgibbon, Ryu, Kilduff, Ormsby

Summary: Narrows the application of the contracting-out requirements under statute to only contracts for services that have been customarily and historically provided by classified employees on or after July 1, 2005, and that would displace or relocate classified employees. Creates additional criteria, with exemptions, for contracting out, including a comprehensive impact assessment, maintenance of certain records, and additional terms in agreements to contract out. Modifies uniform policies and procedures on contract management maintained by the Department of Enterprise Services, including contract termination, minority-and women-owned business participation, performance monitoring, and cost recovery. Prohibits the state from contracting with industry partners that have violated the Law Against Discrimination. WFSE had worked for six years to pass this bill.

### HB 2017: Concerning collective bargaining for administrative law judges.

Sponsors: Frame, Dolan, Fitzgibbon, Stanford, Kilduff, Macri, Ryu, Valdez, Tarleton, Pollet

Summary: Grants administrative law judges of the Office of Administrative Hearings collective bargaining rights under the Personnel System Reform Act. Party line vote in House and Senate.

House Passed: 57-40-0-1 (2/13/20) Senate Passed 29-18-0-2 (3/4/20)

### HB 2691: Concerning the scope of collective bargaining for interpreters.

Sponsors: Valdez, Ryu, Frame, Doglio, Dolan, Slatter, Lovick, Ortiz-Self, Fitzgibbon, Davis, Pollet, Macri

Summary: Expands the scope of collective bargaining for spoken language interpreters to include health and welfare benefits and other economic matters, and provides that bargaining over economic compensation includes tiered payments. Requires certain state agencies to report to the Legislature on the agency's procurement process for spoken language interpreters.

Senate Passed: 32-15-0-2 (3/4/20) House Passed: 61-35-0-2 (3/9/20)

### SB 5022: Granting binding interest arbitration rights to higher education campus police.

Sponsors: Senators Keiser, Conway, Van De Wege, Hunt, Hobbs, Wellman and Kuderer

Summary: The PSRA is amended to provide binding interest arbitration for uniformed personnel who duly sworn police officers employed as members of a police force established by state universities, regional universities, or The Evergreen State College. Republican Representatives Irwin and Griffey

sponsored the House version (HB 1043). WFSE had worked for four years to pass this bill.

House Passed: 68-24-0-6 (4/10/19) Senate Passed: 47-2-0-0 (4/19/19)

HB 1575: An act relating to strengthening the rights of workers through collective bargaining by addressing authorizations and revocations, certifications, and the authority to deduct and accept union dues and fees.

Sponsors: Stonier, Valdez, Ryu, Sells, Chapman, Cody, Macri, Peterson, Kloba, Lovick, Gregerson, Fey, Pollet, Senn, Riccelli, Lekanoff, Fitzgibbon, Bergquist, Stanford, Doglio, Tharinger, Goodman, Jinkins, Frame and Davis

Summary: Provides that public employers and public employee organizations are not liable in claims or causes of action for deducted union fees that were permitted by law before the Janus v. AFSCME decision. Creates provisions for employees to provide electronic or recorded voice authorization to deduct membership dues. Authorizes a cross-check process to determine union representation for certain public employees, upon a showing of interest of 50 percent of the employees in the bargaining unit.

Senate Passed: 25-21-0-3 (4/12/19) House Passed: 56-38-0-4 (4/18/19)

SB 5021: Granting interest arbitration to department of corrections employees.

Sponsors: Van De Wege, Walsh, Keiser, Conway, Hunt, Hobbs, Wellman, Hasegawa and Kuderer

Summary: Employees of DOC, except for confidential employees, nonsupervisory marine department employees, members of the Washington Management Service, and internal auditors, are granted interest arbitration. Republican Representatives Irwin and Griffey sponsored the House version (HB 1042).

House Passed: 83-9-0-6 (4/10/19) Senate Passed: 48-1-0-0 (4/19/19)

SB 5360: Addressing plan membership default provisions in the public employees' retirement system, the teachers' retirement system, and the school employees' retirement system.

Sponsors: Conway, Hobbs, Saldaña, Dhingra, Keiser, Pedersen, Hunt

Summary: Changes the default retirement for new members to the Public Employees' Retirement System, Teachers' Retirement System, or School Employees' Retirement System from Plan 3 to Plan 2. Then-Rep. Stanford was prime sponsor of the House companion (HB 1308). Republican Representatives Griffey and Volz also sponsored the House bill. WFSE had worked for five years to pass this bill.

- Stops the implementation of the Trump administration's Oct 22, 2018, guidance related to Section 1332 of the ACA. Trump's action encouraged states to allow junk insurance plans that do not protect Americans with pre-existing conditions.
- This bill passed by a vote of 230-183. Roll Call vote 196 (R4/D Party-Line)

# H.R. 2157, Supplemental Appropriations: Disaster Aid Package Including Puerto Rico (Supported)

- o First vote, May 10, 2019 RC 202
- This bill passed by a vote of 257-150. Roll Call vote 202 (R34/D Party-Line)

# H.R. 987, Strengthening Health Care and Lowering Prescription Drug Costs Act (Supported)

- Lowers prescription drug prices and reverses actions by the Trump administration to unravel the ACA.
- This bill passed by a vote of 234-183. Roll Call vote 214 (R5/D Party-Line)

- Provides up to 12 weeks of paid leave, extending FMLA to Federal workers, and classifies 911 dispatchers as part of the "protective service operations" by including H.R. 1629, the 911 Supporting Accurate Views of Emergency Services (SAVES) Act as an amendment.
- This bill passed by a vote of 220-197. Roll Call vote 473 (R Party-Line/D8)

## H. Res. 489 – Condemning Trump Racist Comments (Supported)

 This resolution passed by a vote of 240-187. Roll Call vote 482 (R4/D Party-Line)

#### H.R. 582, Raise the Wage Act (Supported)

- Increases the minimum wage from \$7.25 to \$15 per hour by 2025 and indexes the wage to inflation after that. Also eliminates the tipped minimum wage.
- This bill passed by a vote of 231-199. Roll Call vote 496 (R3/D6)

### S.J. Res 54, Second Resolution of Disapproval (Supported)

- Showing disapproval relating to Trump's national emergency declaration.
- This resolution passed by a vote of 236-174. Roll Call vote 553 (R11/D Party-Line)

### H.R. 5377 – Restoring Tax Fairness for States and Localities Act (SALT) (Supported)

- Helping state and local governments maintain their financial stability providing vital public services to all residents. Suspends for two years the temporary 10K cap on federal income tax deduction for personal state and local taxes, including payments for income tax, sales tax, and property tax.
- This bill passed by a vote of 218-206. Roll Call vote 700 (R5/D16)

#### H.R. 5430 - USMCA (NAFTA 2.0) (Supported)

#### H.R. 5, Equality Act (Supported)

- Prohibits discrimination on the basis of sexual orientation and gender, expanding meaningful civil rights legislation for LGBTQ+ persons, et al.
- This bill passed by a vote of 236-173. Roll Call vote 217 (R8/D Party-Line)

### H.R. 1309 – Workplace Violence Prevention for Health Care and Social Service Workers Act (Supported)

 This bill passed by a vote of 251-158. Roll Call vote 642 (R32/D Party-Line)

#### H.R. 4 – Voting Rights Advancement Act (VRAA) (Supported)

- Addressing several components of the VRA that were weakened by the 2013 U.S. Supreme Court decision in Shelby County v. Holder
- This bill passed by a vote of 228-187. Roll Call vote 654 (R1/D Party-Line)

#### S. 1790 - NDAA / FMLA (Supported)

- Providing nearly every civilian federal employee to take 12 weeks paid parental leave to care for their newborn, newly adopted, or new foster placed child.
   Parallels existing guidelines covering parental leave under the Family Medical Leave Act (FMLA).
- This bill passed by a vote of 377-48. Roll Call vote 672 (R189/D41)

### H.R. 3 – Elija E Cummings Lower Drug Costs Now Act of 2019 (Supported)

- Directs our government to stand on the side of all Americans and protect us from price gouging by directly negotiating for lower prescription drug prices. It includes Medicare benefits that cover dental, vision, and hearing.
- This bill passed by a vote of 230-192. Roll Call vote 682 (R2/D Party-Line)

- Increasing labor standards and enforcement mechanisms in the existing trade deal. It also addressed wages in Mexico, implements environmental standards, and eliminates a drug patent protection that would lead to high drug costs.
- This bill passed by a vote of 385-41. Roll Call vote 701 (R192/D38)

### H.R. 1865 – Domestic and International Minibus Budget Deal (Supported)

- Funding deal preventing a government shutdown, repealing 40% excise tax on health plans, and funding miners' pension
- This bill passed by a vote of 297-120. Roll Call vote 689 (R79/D7)
